## TERMS AND CONDITIONS OF SERVICE

### Bookings, Confirmations and costs

1. All bookings are subject to availability at the time of confirming.
2. **You will receive a written confirmation of your booking, or a WhatsApp or SMS if you have not provided an email address. An invoice will accompany or follow this confirmation.**
3. Full payment is due strictly 24 hours prior to departure, or before commencement of the service on short notice bookings.
4. Method of payment is preferred via direct bank transfer (banking details are provided on our invoices), or via SnapScan for quick easy online EFT or credit card payments.
5. We regret that we do not accept any cash or cheques as payment methods.
6. All prices exclude any parking related costs that might occur should a client request a driver to wait – noting that waiting time is charged additionally.
7. Our rate sheet shows rates that are based on 1-2 passengers. Thereafter, we charge R50,00 per additional passenger up to 13. After 8 passengers, we suggest adding a luggage trailer at R 350,00 per way. For groups larger than 13, please contact our reservations team to obtain a customised quotation.
8. All rates are quoted in South African Rand (ZAR) and are valid strictly only for 7 days from the date of issue.
9. Bank charges on international bank transfers are strictly for the clients' account.
10. We reserve the right to take immediate legal action should payment not be received timeously.
11. Kindly note that we cannot dispatch a vehicle without prepayment, and the proof of payment should be sent to [info@capetowngroup.co.za](mailto:info@capetowngroup.co.za) or SMSed/WhatsApped to 0768740288. Please be aware that our office hours are from 08h00 – 20h00 daily and the aforementioned proof of payment should reach us during these hours, particularly on short notice bookings.
12. **Prices are subject to change without notice.**

### Cancellations and Refunds

1. We have a 24 hour cancellation period and for any transfer not cancelled or changed in writing 24 hours before the reserved time, a full cancellation fee will be charged unless otherwise stated.
2. Refunds will be paid as follows:
  - a. 0 – 1 day prior to departure – No refund will be paid
  - b. 2 – 5 days prior to departure – a 50% refund will be paid
  - c. 5 or more days prior to departure – a full refund will be paid**Cancellation terms may differ to the above and will be stated at the time of quotation. This would be in the case of specially requested vehicles and coaches.**
3. Please allow time for refunds as we run payment cycles weekly. For international refunds please allow even more time as this often requires additional documentation and proof for the banks to initiate the international payments from our side.

5. With rescheduling bookings, any increase in rate will be at the clients own account.

#### No-shows and punctuality

1. It is the responsibility of the client to ensure that sufficient time is allowed to arrive at their destination.
2. **In the case of a no-show, the full booking fee will be charged, and we reserve the right to take immediate legal action should payment not be received.**
3. **The driver WILL depart the collection point 15 minutes after the scheduled collection time, except in the case of airport collections where we are aware of the time taken to clear customs and / or collect luggage, and when flights are delayed.** Please be considerate of the fact that our drivers are working on a fixed schedule, and delays will affect other paying clients.
4. **You hereby acknowledge that if (and only if) our schedule allows the driver to wait longer than 15 minutes, you will be charged R350 per hour or part thereof for waiting time.**
5. We request that you contact us telephonically in case of change in flight plans (diverted, cancelled or indefinitely delayed flights). Please keep our contact number at hand: +27 76 874 0288.
6. If a flight is delayed, we will endeavour to monitor the situation and accommodate the change, as we are dependant on information provided to us by the Airport Company of South Africa (ACSA). **However, we will not be held liable for delays caused should ACSA provide us with erroneous information.**
7. Unforeseen circumstances may delay our service. **We request that clients wait 15 minutes after the scheduled collection time before making alternative arrangements.** If your driver is late for your collection by more than 15 minutes, you will not be charged for the transfer.
8. **NB: Please ensure that we have a mobile number of the passenger(s) so that we can liaise with them should we be unexpectedly delayed.**
9. As much as we pride ourselves on our reliability and punctuality, unforeseen circumstances may delay or cancel our service without prior notice. Cape Town Group, their employers, agents associates and any other person indirectly in the employ or service of Cape Town Group will not be liable for any loss, damage, injury, accident, death, delay or inconvenience to any person or their belongings. Cape Town Group reserves the right to refuse to undertake the conveyance of any passengers.
10. There will be no refunds or compensation for entertainment or air-conditioning system failure on our shuttle services.
11. **NB: Any changes to your itinerary or route, or any new / extra bookings must be made with Cape Town Group and not directly with the driver.**
12. If a passenger fails to join a transfer no refund or rebate will be made.
13. In the case of a chauffeur drive package – should the client not make full use of the hours booked, there will be no refund or rebate.

#### Luggage

1. Passengers are allowed to take onto a service one medium sized suitcase or rucksack, and one small item of 'hand luggage' with exception of a passenger with a wheelchair (must be conveyed to booking agent at time of booking). We shall have no obligation to carry luggage in excess of the permitted amount (as per standard airline regulations).
2. Passengers should carry their own personal luggage to the vehicles' luggage compartment. Unaccompanied luggage will not be carried for safety reasons.
3. Cape Town Group carries no responsibility for loss or damage to a passenger's luggage or personal belongings. We recommend that you take out travel insurance from a reputable insurer against all usual and normal risks of loss or damage.
4. Cape Town Group will not be held liable for any incidents whatsoever, to your personal items or luggage.

## Health and Safety

1. The driver has the right to refuse any client who in his/her opinion is a danger to the driver, vehicle or the other passengers.
2. In the interest of Health and Safety, Cape Town Group reserves the right to refuse admission to any of our services where it may hinder the health and safety of fellow passengers.
3. **Smoking and the consumption of alcoholic beverages, or excessive intoxication by use of alcohol or drugs is NOT permitted on our shuttle services under any circumstances** and passengers will be refused boarding at the sole discretion of the driver. In the event of the passenger being refused boarding, the passenger will forfeit any right to a refund or compensation. **Note that any open alcoholic beverages are forbidden by law in any vehicle.**
4. **You will be held fully responsible for valet and/or repair fees should you / your clients sully or damage our vehicles.**
5. No animals without an airport standard carrier are allowed on the shuttle of Cape Town Group with exception of trained guide dogs accompanying an impaired or disabled passenger. Both circumstances would need to be declared at the time of booking.
6. Cape Town Group will not be obliged to carry any child under the age of 13 years unless that child is accompanied by a responsible adult.
7. As per South African Law & Regulation according to the National Road Traffic Act states that all children under the age of three years will have to be strapped into a car seat when travelling in a car. Baby seats are charged at R 150,00 per seat and must be declared at the time of booking.
8. Cape Town Group is committed to passenger safety. Each vehicle is insured with passenger liability insurance. We only employ drivers that have been issued a Professional Driving Permit (PDP), which is obtained after they pass a medical examination and once a police clearance certificate has been issued. Our vehicles are maintained to high specification and are inspected daily by management to ensure your safety.
9. Kindly note that we are bound by the laws set out by the South African Department of Transport. We are issued with road carrier permits annually, which allow us to legally transport passengers. One of the criteria of this permit is that **our vehicles are never under any circumstances allowed to exceed a speed of 100km/hr.** Furthermore, we would love to maintain our 100% passenger safety record, thus we ask for your patience and understanding in this regard. **Bearing this in mind, kindly ensure that you allow sufficient time to reach your destination.**

## Privacy

1. We completely respect your privacy at Cape Town Group and shall take all reasonable steps to protect the personal information of users. For the purpose of this clause, "personal information" shall be defined as detailed in the Promotion of Access to Information Act 2 of 2000 (PAIA).

3. We will never sell, rent or give away your name, email or address to anyone – as per the POPI Act. We will use your email address or contact number only to communicate with you about your orders and information from Cape Town Group.
4. Please note that if you register as a customer, your details will be kept in a secure server for your use the next time you book with us.
5. However, this information is exclusively used for the handling of your orders and for your added convenience. It will never be sold, rented or given away to a third party.

## Other

1. Your invoice serves as confirmation of your booking.
2. Travel routes are decided at the sole discretion of the driver and operations team. Suggestions are welcome, but the driver will decide on the final route, and no discussion to the contrary will be entered into. Unless this specific or alternative route was specially requested and quoted on and booked as such – special instruction will then be relayed to the driver accordingly.
3. All transfers are door to door. A surcharge of R100 will be levied per additional stop en route. Deviations from the route are to be discussed and arranged with the operations team of Cape Town Group.
4. If a luggage trailer is required, an additional R350 will be charged for a standard luggage trailer. For larger trailers, please contact our reservations team in order to obtain a quotation. The trailer size required should be declared at the time of booking.
5. We wish to re-iterate that as much as we pride ourselves on our reliability and punctuality, unforeseen circumstances may delay or cancel our service without prior notice. Cape Town Group, their employers, agents associates and any other person indirectly in the employ or service of Cape Town Group not be liable for any loss, damage, injury, accident, death, delay or inconvenience to any person or their belongings. Cape Town Group reserves the right to refuse to undertake the conveyance of any passengers.
6. All persons entering a Cape Town Group vehicle and / or property owned by Cape Town Group or under its control do so at their own risk.
7. Our call centre is open from 08h00 to 20h00 daily, however our service operates 24 hours a day. Should your booking be outside of our call centre hours, you will be provided with an alternative contact number in case of an emergency.
